

End-User License Agreement

This end-user license agreement (referred to as EULA) is a legal contract between you (referred to as end-user) and GUNMAD Ltd., Guðmundur Úlfarsson & Mads Freund Brunse, United Kingdom (referred to as GUNMAD Ltd.). By downloading, installing and/or using the font software you confirm that you have read and accepted this EULA.

1. LICENSE

GUNMAD Ltd. hereby grants you a limited and non-exclusive license to install and use the font software specified on your invoice. You may install and use the font software on a specified number of workstations which belong to the company purchasing the license. The number of workstations that are covered by this license must be specified in the invoice. You may install the font software on a protected server only. The font software may NOT be installed or used on a server that can be accessed via the Internet or another external network system. The end user is allowed to create one (1) copy for back-up use only.

The end-user undertakes not to change any trademark or trade name of the licensed font software for the purpose of identification for similar or identical products to the licensed font software.

You are allowed to send a copy of the font software to a printer or any service company for final output. The printer or the service company will have to destroy any copy of the font software upon completion of the work. You further agree to inform the printer or other service company about the content of this EULA.

All fonts purchased with this license will be delivered as OpenType format and are optimized for professional graphic design applications like the Adobe Creative Suite. We do not guarantee support for Office Applications like Microsoft Word.

2. INTELLECTUAL PROPERTY RIGHTS

This font software is licensed to the end-user not sold. This means that GUNMAD Ltd. retains title and copyrights to the font software and accompanying documentation. The font software is the intellectual property of GUNMAD Ltd. containing proprietary information and valuable trade secrets, and as such they are protected by the copyright laws of many nations, and by international treaties. The end-user hereby undertakes not to copy, rename, resell, redistribute, transfer by any technical means to third parties or to modify in any way the font software or its design.

3. EMBEDDING

Embedding of the font software into your electronic documents is only allowed for viewing and printing, NOT for editing. The EULA does entitle under no circumstances the end-user to broadcast digital documents with embedded licensed Fonts over computer networks, including but not limited to publicly accessible Internet pages (CSS @font-face rules) or any other public media, Flash documents, DVDs, game playing devices, electronic books, mp3 players, mobile phones or mobile devices. The embedding of the font software will require the purchase of a special license.

4. WARRANTY AND LIABILITY

GUNMAD Ltd. warrants that the font software will perform in accordance with the installation information provided on its Website. The font software may be returned or exchanged only if defective and will be replaced only when accompanied by a valid sales receipt within thirty (30) days of purchase.

GUNMAD Ltd. shall under no circumstances be liable to the end-user for any consequential, incidental or special damages, including any lost business profits or for any claim by any third party. GUNMAD Ltd. does not warrant you the results you may obtain by using the font software.

5. TERMINATION

However, this Agreement will terminate automatically if you fail to comply within its terms. In this case you must stop using the font software and destroy all copies of the font software and certify that no copies remains in your possession or control. This Agreement is valid in all territories and has no expiration date. Any dispute regarding the validity, performance or interpretation of this agreement shall be subject to the exclusive jurisdiction of the courts of the United Kingdom.
